- You must be at least 18 years of age by the date of the 2019 Virgin Money London Marathon.
- There is a minimum pledge of £2000 in sponsorship along with a £50 registration fee. We require you to send at least 50% of your sponsorship money (including any on-line donations through Just Giving) one month before the marathon date. The remaining sponsorship should be sent to us by the end of July 2019.
- The Get A-Head Charitable Trust is obliged to report anyone who fails to raise the minimum sponsorship amount to the London Marathon. This could affect your chances of competing in any other London Marathon Event.
- Should you choose to withdraw, you may return all your sponsor forms and forward monies raised to Get A-Head (provided your sponsors agree to this) or return the monies to your sponsors. Your registration fee of £50 will not be refunded.
- You confirm that to the best of your knowledge your general state of health and fitness is good and you take full responsibility for your actions prior to, during and after the London Marathon.
- Please note Gift Aid does not count towards your sponsorship total.
- Photographs and video footage will be taken at this event and may be used for publicity purposes.
